We've begun our new graduate and research Scholarly Initiatives centered around: Civic Engagement, Health & Well-being, Identity & Difference: http://comm.unl.edu/ files/grad/CS%20Emphases%2C%20Strat% 20Initiatives%207%2019%2013.pdf. We have excellent research going on, especially faculty-student collaborations. Our accomplishments pages feature Top Papers, publications and presentations. Dr. Damien Pfister and colleagues in Global Studies and the Center for Civic Engagement received a grant from the U. S. Department of State. Faculty members have national-level grant applications under review for research in narrative medicine and multi-ethnic identity. We kicked off our redesigned COMM 286 (formerly 311) course. Under the direction of Professor Kathy Castle,

the course, an innovative online and FTF blended design, serves over 1200 students per year. Drs. Damien Pfister and Carly Woods head our first Learning Community. We rolled out revisions to the undergraduate program, including our new general education COMM 101, Communication in the 21st Century taught by Dr. Aaron Duncan. Dr. Jody Kellas and the Undergraduate Committee are hosting our second COMM Careers week. Our Speech & Debate team kicked off the fall semester with a "Three-peat" as winners of the Big Ten Tournament and are off to a great year. We were delighted to host the British National Debate Team on October 23rd, debating doctoral students Jon Carter and Jessy Ohl on the topic of government surveillance. More than 300 people attended the debate. Our graduate program continues to thrive directed by Dr. Jordan Soliz. A large number of doctoral students will graduate this year and we added excellent new students.

From the Director of Undergraduate Studies


We have had a lot going on "behind the scenes" in the undergraduate program, and I wanted to take this opportunity to share some of the great ideas, changes, and outcomes that have come of that work.

As you have probably already seen, we updated our website some time ago to better showcase the Department of Communication Studies. One of the pieces we think is most exciting is the interactive tool on the undergraduate page. Students, potential students, parents, and anyone else interested in the pathways possible with a COMM major can go to http://comm.unl.edu/ugrad and mouse over any of the possible pathways (i.e., careers) in the right hand column to light up a path of courses that might best prepare students for those careers. Because we believe in the importance of a flexible major that allows students to follow their own paths, none of these courses is required. However, students love the guidance that this tool provides and the ways in which it visually helps them map out their major with a possible end goal-a career-in mind!

This focus on careers is central nationally and at UNL. In November, we feature our second annual COMM Careers Week during which students can explore the many internship opportunities available to supplement their coursework in the major and the many career possibilities available to COMM graduates. Once again, we are partnering with UNL's Career Services to help students achieve their career goals.

Finally, we have thought carefully about how to best enable our students to gain competencies in Advocate, Negotiate, and Relate (ANR). To that end, we developed a new introductory course: COMM 101: Communication in the 21st Century. This course takes a problem-centered learning approach and provides students with an understanding of how communication can be applied to solve everyday problems we face in our public, professional, and private lives. With 101, students in and outside the major will build a foundation of ANR competencies. We also are developing new 200-level foundational courses in each of these areas that will allow students to gain more in-depth understanding of advocacy, negotiation, or relating and further fortify the scaffolding of their knowledge before moving into their upper division courses.

We are excited about all of these advancements and the ways in which they will not only help students secure fulfilling careers, but also the ways in which they will enrich their experiences throughout their college career.



Spotlight on Graduate Alumnus Dr. Paul Schrodt Professor of Communication Studies at Texas Christian University



Dr. Paul Schrodt is the Philip J. & Cheryl C. Burguières Professor of Communication Studies at Texas Christian University. Dr. Schrodt was awarded the 2012 Bernard J. Brommel Award for Outstanding Scholarship in Family Communication from the National

Communication Association, the 2011 Early Career Award in Interpersonal Communication from NCA, and the inaugural Sandra Petronio Dissertation Award from NCA's Family Communication Division.

1. When did you earn your degree at UNL?

I attended UNL from the fall of 2000 until the summer of 2003, at which time I graduated with my Ph.D. in Communication Studies with an emphasis in Interpersonal & Family Communication.

2. Why did you choose a degree in Communication Studies?

As an undergraduate student, I bounced around different majors until I completed my first course in interpersonal communication. I fell in love with the subject of communication and personal relationships, and that prompted me to switch majors from Mathematics to Communication Studies.

3. What brought you to study Communication at UNL?

Quite simply, the people – I attended my first NCA convention in 1999, and I met Dr. Braithwaite and several other graduate students during the convention. I really enjoyed

the conversations (and the fit) I had with the faculty and students at UNL, and that led me to choose UNL for my Ph.D. program.

4. What have you been doing since leaving UNL?

I am the Philip J. & Cheryl C. Burguières Professor of Communication Studies at TCU and I serve as the Graduate Director for our department. My wife (Danielle) and I have two sons (Isaac and Eli), and we spend most of our "spare" time watching the boys play sports.

5. What is a favorite memory of your time in Communication Studies at UNL?

Tailgating at Husker football games with friends and colleagues! I had season tickets all three years I attended UNL, and my favorite memory was attending the 2002 Rose Bowl game in Pasadena and tailgating all day with Dr. Seiler.

6. In what ways can alumni support our department and students?

An important way that we can support our department is by giving scholarships to students and other donations to support the faculty in their research and teaching activities. Another way that we can support our department is by staying connected through social media.

7. What advice do you have for current undergraduate/graduate students in our department?

For undergraduates, participate in an internship that provides professional experience in a field that you may want to pursue after graduation. For graduate students, cultivate your relationships with your peers and with the faculty so that you build a strong, supportive network of colleagues.

Research In Action



Katherine Castle

UNL doctoral student Katherine M. Castle and Dr. Jordan Soliz have collaborated on the research project, "Voice of Medicine and Voice of the Lifeworld: Outcomes of Physician and Patient Convergence in the Medical Encounter." Based on the

movement in both medical and academic circles toward identifying the potential benefits of patient-centered care which is driven by the needs and concerns of the patient, the purpose of this study was to investigate the manner in which physician and patient communication affect perceptions of the medical encounter.

Patients and physicians come to the medical encounter representing distinct groups characterized by distinct "languages"— the *voice of medicine* and the *voice of the lifeworld*—that may serve as a barrier to effective medical encounters.

In order to explore how convergence in the medical encounter influences patient perception of the physician, patient and medical encounter, Castle and Soliz framed this study using Communication Accommodation Theory. In collaboration with local physicians, they constructed three scripts depicting a patient being diagnosed with asthma. One script demonstrated the physician converging to patient language, another represented the normative medical encounter (patient and physician maintaining their distinct languages), and the last script depicted the patient converging to the physician's language. Participants read one of the three scripts, and then responded to an online survey. The researchers found that when either physicians or patients adopt one another's language (a) the medical encounter is perceived to be more desirable, (b) perceived physician credibility and engagement increases, (c) perceived patient competence and

engagement increases, and (d) patients are perceived as more likely to comply with medical advice. Patient competence and engagement were highest when patients adopted the physician's language, followed by when the physician adopted patient language. Perceived

physician power was highest in the normative condition and in the condition where physicians adopted the patient language, but decreased in the condition where patients adopted physician language.

Reflecting on the practical applications of this research, Kathy Castle remarked, "These results

demonstrate that both physicians and patients can contribute to a more positive healthcare experience through their communicative choices, highlighting the importance of a partnership between the physician and the patient in a patient-centered healthcare system. Further, as patients use medical language to discuss their conditions with their physicians, the physician effectively loses power in the interaction. Further research should examine the ways in which physicians negotiate the shifting power balance in patient-centered healthcare interactions."

Communication degree in his career every day.

1) During which years were you a student at UNL and when did you graduate? Which degree(s) did you earn at UNL?

I was at UNL 1997 to 2002, earning my B.A. in Communication Studies, followed by my M.B.A in 2006.

2) What have you been doing since leaving UNL?

I've worked in Enrollment Management at the University of Nebraska-Lincoln and now at the University of Connecticut as the Director of Admissions.

3) Why did you choose a major in Communication Studies?

I changed my major from Agriculture to Communication Studies after taking an introductory course in Communication Studies. For the first time in the classroom, I was able to pair learning with fun.

4) How has your communication degree helped you in your life and career? I emphasize to our team that effective communication is a process. No one

communicates perfectly all of the time, and when we are stressed, the 'hard wired' tendencies, in particular, the more ugly ones, come out. My degree has helped maintain a focus on constantly improving our communication to effectively advocate, negotiate and relate to achieve our goals.

5) What is a favorite memory of your time in Communication Studies at UNL?

I recall how Ron Lee's course pushed me intellectually. I realized that I enjoyed being pushed in this way. I recall a high level of satisfaction on what I learned and accomplished in that particular course. This helped to shape a work ethic that has continued to reward thus far in my career.

UNL Speech & Debate Team Wins Swing Tournament



The UNL Speech & Debate Team's season got off to great start with a win at the Hutchinson and Sterling College Swing Tournaments in Hutchinson, Kansas. The tournament was attended by a total of eighteen schools from across the Midwest. UNL placed 1st in the team division of Lincoln Douglas Debate, 2nd in Speech, and 1stoverall for the combined portion of the swing. The team's victory was highlighted by individual wins by senior Josh Planos (communication analysis, informative speaking) and senior Grace Kluck (prose interpretation). The debate team compiled an overall record of 35-20 for the weekend and placed three speakers in the top five: junior Jeff Garst (3rd

place), junior Derrick Stevens (4th place), and freshmen Kelsey Maher (3rd place novice division). The tournament was highlighted by junior Jeff Garst's perfect 7-0 record on his way to capturing 1st in the varsity division. In addition to a great freshmen class, the team welcomes a new graduate student coach, Jonathan Carter. Jonathan is joined by second year graduate assistant coaches Amy Arellano, Allison Bonander, Jamie Downing and fourth year graduate assistant debate coach Darrel Farmer. Director of Speech & Debate Aaron Duncan is returning for his ninth year with the team. On October 12-13th the team traveled to Northwestern University and repeated as champions of the Big Ten Tournament.
