

2008 ID Application Procedure

Application Procedure: Applications must be submitted with:

- ⇒ One passport-size photo (with name on the back printed in pencil).
- ⇒ Check or money order: \$22.00 fee for Student card; \$22.00 fee for the Teacher Card; \$22.00 for the GO 25 Card. For mail orders, add \$1 for postage and handling.
- ⇒ Proof of academic status.
- ⇒ Proof of identity and age.

Eligibility and Proof of Academic Status

Student Card: You must be in a junior high school, high school, college, university, or vocational school or a student at least 12 years of age and enrolled in a study program leading to a diploma or degree at an accredited institution during the 2007-2008 academic year.

1. If currently a UNL student, International Affairs will verify registration.
2. If not currently a UNL Student, provide one of the following:
 - A. Letter on school stationery from the registrar or dean (with school seal) stating you are enrolled during the 2007-2008 academic year at an accredited institution and working toward a diploma or degree.
 - B. Photocopy of transcripts for current academic year.
 - C. Bursar's receipt with school seal indicating full payment for current academic year.
 - D. Report card or letter on school stationery from principal or guidance counselor stating you are enrolled in junior or senior high school for the 2007-2008 school year.

Teacher Card: You must be a full-time faculty member at an accredited institution during the 2007-2008 academic year.

1. If currently a UNL faculty member, International Affairs will verify employment.
2. If not currently a UNL faculty member, provide one of the following: letter on school stationery from department chair, school principal, or other school official stating you are a full-time faculty member during the 2007-2008 academic year.

Proof of Identity and Age

1. If applying in person, issuing office may ask for photo identification which includes date of birth.
2. If applying by mail, submit a clear photocopy of photo identification which includes date of birth.

Validity Period:

The 2008 International Student and Teacher Identity Cards are valid through December 31, 2008. The GO 25 Cards are valid for one year from date of issue.

Note:

No refunds for lost or stolen cards.
