

**RULES AND REGULATIONS FOR USE OF MEMORIAL STADIUM
OF THE UNIVERSITY OF NEBRASKA-LINCOLN**

Scope: This policy applies to Memorial Stadium of the University of Nebraska-Lincoln and its component facilities. It sets forth the rules and regulations of the University for use of that facility, including the skybox and press box areas, the facilities of the Hewitt Food Center, and all administrative, academic, conditioning and training facilities.

1. **General.** Memorial Stadium is the historic and legendary home of the Nebraska Cornhusker Football Team. It is the intent of the University by these rules and regulations to preserve and protect the primary use of Memorial Stadium for football play and practice, while permitting limited use for other events sponsored by the University.

2. **Regulations for Use of Playing Field, Spectator Stands, Locker Rooms, and Press Box Facilities, and Administrative, Academic, Conditioning and Training Facilities.**

A. **Spectator Stands and Playing Field.** The spectator stands and playing field shall be used only for the following purposes:

1. University use for intercollegiate football purposes.
2. University use for other intercollegiate or intramural athletic purposes approved by the Director of Intercollegiate Athletics.
3. Use by other organizations for football games or other athletic events approved by the Director of Intercollegiate Athletics, such as the annual Nebraska State High School Football Championships and the annual Shrine Bowl Football Game.
4. Use for University events or University sponsored events approved by the Director of Intercollegiate Athletics.

B. **Locker Rooms and Press Box Facilities.** The locker rooms and press box facilities shall be used only for the following purposes:

1. University use for intercollegiate football purposes.
2. Use by the University or other organizations for football games or other athletic events approved by the Director of Intercollegiate Athletics, such as the annual Nebraska State High School Football Championships and the annual Shrine Bowl Football Game.

C. **Administrative, Academic, Conditioning and Training Facilities.** The administrative, academic, conditioning and training facilities of Memorial Stadium shall be used exclusively for University purposes or University sponsored events as approved by the Director of Intercollegiate Athletics.

3. **Regulations for Use of Skybox Area (Excluding Skybox Suites) and Hewit Food Center.**

A. **Skybox Area.** The skybox area (excluding the skybox suites) shall be used only for the following purposes:

1. University use for intercollegiate football games.
2. Use by the University or other organizations for football games or other athletic events approved by the Director of Intercollegiate Athletics, such as the annual Nebraska State High School Football Championships and the annual Shrine Bowl Football Game.
3. Use for an event approved by the Director of Intercollegiate Athletics sponsored in whole or in part by the University, the University of Nebraska Foundation, the Husker Athletic Fund (or any of its constituent organizations), a skybox suite holder, or a stadium club seat holder.

B. **Hewit Food Center.**

1. University use as a student and staff food service facility.
2. Use for an event approved by the Director of Intercollegiate Athletics sponsored in whole or in part by the University, the University of Nebraska Foundation, the Husker Athletic Fund (or any of its constituent organizations).

4. **Stadium Tours.** Notwithstanding other provisions of these rules and regulations, Memorial Stadium may be used for guided tours for outside organizations and groups that do not interfere with the University's use of the stadium. All such tours must be arranged by appointment with the Department of Intercollegiate Athletics and are contingent upon the availability of one or more members of the Department's staff who must be present to conduct the tour.

5. **Films and Pictures.** Memorial Stadium as a recognized landmark public building is often used for filming and the taking of pictures by individuals, commercial firms and political campaigns. Such use is not prohibited as long as the resulting film or pictures are not used so as to create confusion or deception as to University sponsorship, endorsement, or other association with the activity depicted, or its sponsor.
