The hearing was held at the City Campus Nebraska Union at University of Nebraska–Lincoln.

Eckhardt opened and called the meeting to order at 2:00 p.m. He explained the Academic Planning Committee (APC) scheduled two separate hearings - today and September 18th - to discuss the University of Nebraska-Lincoln's FY2010 proposed budget reductions proposed by Chancellor Harvey Perlman. He stated today's hearing is primarily focused on the proposed administrative reductions. He explained the purpose of this hearing is one of fact finding and to give those interested parties who may be affected by the proposed reductions an opportunity to come before the APC to provide testimony, either pro or con, on the given proposed reduction.

Eckhardt outlined the procedure for the hearing, noting the APC would have the opportunity to ask questions following each presentation. He asked that the presenters stick to the facts. He conveyed, for those in attendance who did not submit a written intent to appear at today's hearing, there would be time provided at the end of these proceedings to address the Committee. He mentioned the APC would meet at a later date to consider the present reductions on today's agenda and briefly explained the role of the APC in the budget reduction procedures.
