THE NPRM COMMENT PROCESS

TITLE IX REGULATIONS

- Congress passed Title IX of the Education Amendments in 1972
- Since 1980, the Department of Education's Office for Civil Rights (OCR) has had primary responsibility for enforcing Title IX
- November 2018: OCR proposed the most detailed and comprehensive Title IX regulations to date¹
- August 2020: Significantly amended, due-process oriented Regulations took effect (proposed in Nov. 2018)
- June 2022: OCR published the Notice of Proposed Rule Making (NPRM) outlining proposed changes to the Title IX regulations
- On July 12, 2022, the NPRM was published in the Federal Register and the 60-day comment period began

APA & THE RULEMAKING PROCESS

- Administrative Procedures Act (5 U.S.C §§ 551-559)
 - Federal statute which sets forth process federal agencies (OCR) must use when establishing new regulations: The "Rulemaking" process
 - Main elements of rulemaking process:
 - Notice of Proposed Rule Making (NPRM; published in Federal Register)
 - Window of time in which interested individuals may participate in process through submission of comments
 - Consideration by agency; also OMB review
 - Adoption and publication of rules, with a statement of their basis & purpose

SUMMARY

- Official publication in the Federal Register July 12, 2022
- Review and comment period
 - 60-day comment period ends September 12, 2022
 - Submit comments to the Department of Education's Office for Civil Rights (OCR)
- Final Rule expected to be issued in Spring 2023
- Effective Date approximately Summer/Fall 2023
- Watch for ATIXA webinars and other opportunities ⁽³⁾

EFFECTIVE COMMENTS

- Reflect understanding of the intent and actual impact (i.e., you actually read the proposed regulations)
- Are organized:
 - By heading, and/or
 - Referencing specific subsections of the proposed regulations
- Respond to questions posed/topics raised in the NPRM
- Include statistics, hypothetical scenarios, and personal experiences to illustrate anticipated effects
- Demonstrate respectful disagreement with specific proposals and other commenters, when appropriate

EFFECTIVE COMMENTS (CONT.)

- Remember: the agency only has authority to regulate within the bounds of the statute. Certain proposed regulations may exceed that authority.
 - Ultra Vires: acting beyond the legal authority (provided to the agency)
 - No requirement to comment on every portion of the proposed regulations – write about what you know and what impacts you
 - "Many in the public mistakenly believe that a submitted form letter constitutes a 'vote' regarding the issues concerning them. A single, well-supported comment may carry more weight than a thousand form letters."²

WHAT TO EXPECT AFTER THE COMMENT PERIOD?

- The agency may choose to publish a supplemental rule if sufficiently serious questions or challenges are raised which require adjustments to the proposed rule.
- When the proposed rule is finalized, it will be published again, along with an effective date of enforcement, typically 30-60 days from the date of publication.
- If the agency decides to publish a final rule, it has several responsibilities related to the comments it received.
- The final rule must include substantive responses to questions and criticisms, and provide explanations for why the agency declined to incorporate suggested changes.

- 6 Pregnancy and Related Conditions (§ 106.40, § 106.57)
- **7** K-12 School/District Requirements (various § 106)

PREPARING FOR IMPLEMENTATION

- Must continue to fulfill obligations under the current regulations for the 2022-2023 academic year.
- Anticipate OCR will expect schools to implement the new Title IX regulations before the start of the 2023-2024 academic year.

Steps to Take Now:

- Prepare to educate your community on the changes
- Identify stakeholders that will need to be involved in making policy decisions (e.g., whether to have hearings)
- Determine how you will manage policy changes
- Plan for the training needs for your community
- Consider state laws, court decisions, and other regulations that may affect your institutional approach
