MEMORANDA OF UNDERSTANDING

- An agreement outlining the terms of a relationship to establish and clarify expectations between the parties that may be relied upon
 - Similar to a contract, but generally not legally enforceable
- Common MOU partners:
 - Campus or local law enforcement agency, prosecutors
 - Local crisis or advocacy services
 - Dual enrollment partner(s)
 - Internship/Co-Op/Placement sites
 - Hospitals
 - Camp and Conference hosts

DESIGNING THE MOU

- Collaborative process
 - Directed, structured
 - Defined goals
 - What can you offer the other parties?
- May use a template, be prepared to customize
 - Be specific who is the go-to person?
 - Process coordination and overlap
- Anticipate pain points
 - Local rules and state law vs. federal regulation
- Durability
 - Staffing changes
 - Budget cuts



DESIGNING THE MOU (CONT.)

- Use existing MOUs as starting point
- Use terminology that all parties understand
- Clarify that any party may seek to update the document at any time
 - Plan to revisit the document on an annual basis to ensure the agreement still describes the needs and expectations of all parties
