CALL TO ORDER

President Karen Da Silva called the meeting to order at 7:01pm on Oct. 3rd in the Centennial Room of the Nebraska Union.

Absent were Master of Applied Science, College of Architecture, Finance, Management, Natural Resources, and Statistics.

ALEC, Educational Administration, Law, and Special Education, Communication Disorders and MS Environmental Engineering were excused.

APPROVAL OF THE MINUTES

Minutes from September 5 and 19, 2017 were unanimously approved as distributed.

OPEN FORUM (15 minutes)

IT Services and Student Information Systems spoke to the GSA about a new initiative to require all students including graduate students to use university email addresses.

Counseling and Psychological Services (University Health Center)

Dr. Stephen Baenziger (Professor and CASNR Interim Associate Dean for Graduate Education) requested Graduate Students contact him with any ideas to improve graduate education at Nebraska, saying that CASNR is an experiment—they want grad school at Nebraska to be second to none and have resources available that other units may not have.

Marlene Beyke (ASUN Advisor) provided the GSA with a primer on Parliamentary procedure.

EXECUTIVE REPORTS

President Da Silva

Executive Vice President Clausen reported that he would be attending the Graduate Council and asked for anyone with announcements or concerns to share them with him.

Vice President of Student Affairs Reilly reported that Donde Plowman is meeting with students in an effort to respect the existing and wide diversity of the student body and help all students feel respected.

Vice President of Representation Poudel reported that there several open representative positions remain open, and encouraged graduate students to apply.

Vice President of Finance Twedt had nothing to report.

COMMITTEE REPORTS (10 minutes)

Graduate Travel Awards Program Co-Chairs Brown and Vorhees reported that the GTAP application period was open, and encouraged graduate students to apply or volunteer to be reviewers. They asked representatives to distribute the call for reviewers in their own department.

Vet Medicine asked if GTAP funds could be used to travel to conferences not involving presentation of original research, GTAP answered that this was not possible at this time.



UNFINISHED BUSINESS (10 minutes)

Pursuant to GSA Bill #6: The draft of a letter to be conveyed to the administration regarding graduate student rights was presented to the Assembly. Technical and procedural difficulties prevented all representatives from being able to see or productively debate the final draft, or agree on its language. Sarah Erwin (Child Youth and Family Studies) moved that “Any GSA representative interested in editing the letter can submit their edits until Tuesday, October 10. After that week, a final version of the letter will be sent out to be voted on. This vote will take place over email, instead of at the November meeting.” This motion was seconded and passed by voice vote. The final draft was approved by email on Oct. 13th, and sent to the administration on Oct. 16th. Voting results were:

- 41 departments voted YES;
- 1 department voted NO;
- 1 department voted ABSTAIN;
- 20 departments did not vote;

BUSINESS (10 minutes)
